Extension of Vehicle Lease Warehouse Agreements

On August 16, 2018, certain subsidiaries of Tesla, Inc. ("<u>Tesla</u>") that are respectively parties to (i) an Amended and Restated Loan and Security Agreement (the "<u>A&R 2016 Warehouse Agreement</u>") and (ii) a Loan and Security Agreement (the "<u>2017 Warehouse Agreement</u>," and together with the A&R 2016 Warehouse Agreement, the "<u>Warehouse Agreements</u>"), each dated August 17, 2017 with Deutsche Bank AG, New York Branch as administrative agent and the other parties named therein, entered into an amendment to each of the Warehouse Agreements (together, the "<u>Amendments</u>").

Among other changes, the Amendments extended the borrowing availability date under the Warehouse Agreements from August 17, 2018 to August 16, 2019 and extended the maturity date of the Warehouse Agreements from September 2019 to September 2020. The aggregate lender commitment, which is shared between the Warehouse Agreements, remains unchanged at \$1.1 billion.
